#### Border Development Corridor -The Need for Action

- History of underinvestment, back-to-back policy development, legacy of a troubled history, and weak regional development policies
- Hit hard by the economic crisis unemployment in the southern Border Region rose from 14,100 in 2007 to peak at 37,200 in 2012 (McDonagh, 2013)
- Unemployment in the Strabane and Derry council areas the highest in Northern Ireland – respectively the 2nd and 3rd most deprived council areas (NI Multiple Deprivation Index, 2010)
- Border regional economy dependent on agriculture, manufacturing and construction – less on services and public sector – increasing urbanrural divide evident
- Also an opportunity to capitalise on the economic, social and environmental assets of the Border region

# Seven key recommendations within Report

- 1. A master planning process for the long-term development of greenways and cycle routes in the Border region should be initiated to guide strategic decision-making.
- Strategic coordination should be established to plan for, and implement, the development of a regional network of greenways and cycle routes on a cross-border basis.
- 3. More explicit policy references are required in national/regional level documents to support the master planning and implementation of cross-border cooperation in the provision of cycling infrastructure.
- 4. More explicit policy references are required in local authority level documents, particularly in Northern Ireland, to support the provision of cycling infrastructure on a cross-border basis.
- 5. An inclusive approach should be taken to defining strategic priorities and prospective outcomes in the development of a regional network of greenways and cycle routes on a cross-border basis.
- 6. Further research and engagement is needed on key issues pertinent to the development of greenways and cycle routes on the island of Ireland, particularly concern in innovative approaches to funding.
- 7. Key stakeholders in both jurisdictions should convene at the earliest opportunity to define priorities and determine an agreed course of action in the development of a comprehensive greenways and cycle route network in the Border region.
